

1. This Privacy Statement governs the processing and securing of personal information Hire All collects from their customers.
2. "Personal information" means information that identifies you, such as your name, telephone number and email address.
3. Personal Information we request may include your email address, name, copies of ID documents, registration vehicle details and copies of the license disc, banking details as required for processing of refunds, home address and telephone number. If you make a hire, we may ask for your credit card number and billing information. We may also ask for your financial background data to process your credit request.
4. Hire All uses your personal information to:
 - ▲ Deliver the services and support or carry out the transactions you have requested
 - ▲ Send communications to you, such as product safety information, your transaction status including order confirmations, information about products and services available from Hire All, promotional offers and surveys
 - ▲ Facilitate communications from authorised third parties
 - ▲ Customise, analyse and improve our products, services (including the content and advertisements on our website), technologies, communications and relationship with you
 - ▲ Enforce our conditions of sale, website terms and/or separate contracts (if applicable) with you
 - ▲ Prevent fraud and other prohibited or illegal activities
 - ▲ Protect the security or integrity of our website, our business, or our products or services
 - ▲ Or otherwise, as disclosed to you at the point of collection.
5. Hire All may use your personal data for debt enforcement, recovery, collection, repayment, surrender and cession of debts.
6. Except as described above, Hire All will not disclose your personal information to third parties for their own marketing purposes without your consent.
7. If you have any questions about the type of personal information Hire All holds about you, or if you wish to request deletion or amendment of personal information Hire All holds about you, or exercise your rights to access and/or object to the processing of your personal information, please send a written request to paul@hireall.co.za.
8. Hire All takes all reasonable steps to protect your Personal Information from misuse, interference and loss, as well as unauthorized access, modification or disclosure. The ways we do this include:
 - ▲ Using encryption when collecting or transferring sensitive information, such as credit card details
 - ▲ Limiting physical access to our premises
 - ▲ Limiting access to the information Hire All collects about you to required staff members
 - ▲ Ensuring that Hire All and their authorised third parties have appropriate security safeguards to keep personal information secure.
 - ▲ Training of all staff in the need of and how to protect the personal information of customers
